

SUMMARY ORDER
21 MC 100 (AKH)

ALVIN K. HELLERSTEIN, U.S.D.J.:

On February 2, 2011, I held a status conference in the above-captioned Master Calendar, to address the progress of implementing the terms of the Settlement Process Agreement, As Amended (“SPA”) and to begin managing cases of Plaintiffs who chose not to settle, and of Plaintiffs who were ineligible to settle. The following topics were raised and discussed.

1. The parties signed the Affirmation of Final Settlement on January 5, 2011. Since that date, the Allocation Neutral has approved initial payments of \$10.2 million to approximately 4,827 Plaintiffs, and directed the WTC Captive Insurance Company (“WTC Captive”) to remit that money to Plaintiffs’ Liaison Counsel for distribution to individual Plaintiffs. The WTC Captive has done so. Plaintiffs’ Liaison Counsel has sent checks to approximately half these Plaintiffs, and represents that checks will be sent to the other half imminently. I stressed the need for all settling Plaintiffs to begin receiving settlement funds quickly, consistent with the terms of the SPA. The parties agreed, and are proceeding in good faith and with dispatch. The parties also informed me that the completions of all other settlements in this Master Calendar are proceeding apace.

2. Various Plaintiffs' counsel raised two issues that could affect the ability of the Allocation Neutral to continue making timely payment instructions. First, the SPA requires Plaintiffs to submit certain claim forms evidencing their injury claims, which the Plaintiffs' lawyers have been able to complete and submit to varied degrees. Second, the Allocation Neutral claims to be slowed by the current dispute over the common benefit fee that Plaintiffs' Liaison Counsel, Worby Groner Edelman & Napoli Bern LLP, seeks from non-liaison counsel. On the first issue, I asked counsel to meet with clients to complete all claims forms. A motion will be required to extend any dates. On the second issue, I expressed skepticism that the common-benefit fee issue had anything to do with the Allocation Neutral's work, since the issue has nothing to do with the net amount the Allocation Neutral must allocate to fees generally. In any event, I have received all briefing on that issue and a decision will be forthcoming.
3. I reiterated my concern, first stated at a status conference held in October 2010, that certain Plaintiffs, approximately 55 in number, had participated in the first Victim Compensation Fund. To assist these Plaintiffs, I appointed Noah H. Kushlefsky of Kreindler & Kreindler LLP, to represent these Plaintiffs. A separate order appointing Mr. Kushlefsky discusses the issue.
4. The parties raised other issues that are the subject of separate motions: the issue of incentive compensation covered by my order of December 30, 2010, which is the subject of objections and responses, and related issues having to do with voluntary and involuntary dismissals and orders regarding them. The issues are sub judice, and will be discussed and resolved in an opinion to be issued.

5. There also are issues regarding three categories of individuals who were dismissed for failure to prosecute their cases, but who wish to reinstate their cases. First, Plaintiffs' Liaison Counsel seeks to reinstate nineteen Plaintiffs who expressed a desire to join the SPA after the date of Final Settlement Affirmation. I ordered Plaintiffs' Liaison Counsel to submit a brief on the issue by February 9, 2011. Defendants shall respond by February 16, 2011. A second category, approximately two in number, reflects individuals who were involuntarily dismissed for failure to prosecute, but who now wish to continue litigating. A third category reflects individuals who were involuntarily dismissed, and who wish to change the dismissals to voluntary dismissals in the belief that they will be aided for purposes of claims under the Zadroga Act. The second and third categories, although unopposed, will be the subject of reviews by me and resolution by the opinion described in the previous paragraph.
6. The overwhelming majority of settling Plaintiffs have submitted enrollment forms for the cancer insurance policy provided by MetLife under the SPA. This cancer insurance policy accrued on the date of the SPA's affirmation, January 5, 2011. Some enrolling Plaintiffs have not yet been approved for the policy because of deficiencies in their enrollment papers. A motion will be required if the applications are not completed by the deadline.
7. Now that the SPA has been affirmed and most cases in this litigation have been dismissed, the question arises how to manage the remaining cases. There are two categories of cases remaining. First, there are the cases of Plaintiffs who opted not to settle. The parties represent that there are between 74 and 79 such

Plaintiffs. Second, there are new cases, of which there are between 129 and approximately 250. All parties suggested that all litigation on these cases should be stayed while regulations are promulgated for the James Zadroga 9/11 Health and Compensation Act of 2010 (“Zadroga Act”), H.R. 847, 111th Congress (2010). These regulations, it is believed, will help Plaintiffs decide whether to enter the reopened VCF or continue with their cases. As to the cases of continuing Plaintiffs, I noted a tension between my obligation to provide a day in court to any Plaintiff who genuinely wants it and my reluctance to allow litigation to serve extraneous needs and goals. As to the new cases, I expressed a belief that timely motion practice, evaluating whether any of the new cases satisfied the pleading requirements of the Federal Rules of Civil Procedure, might be preferable to maintaining swollen lists of possibly unmeritorious cases. The issues were not resolved.

8. Defendants are currently preparing for my review a modified Case Management Order (“CMO”) to govern discovery proceedings going forward. Though I did not raise this at the conference, a fair question exists why Defendants wish to implement a new CMO at the same time they wish to stay all proceedings pending the Zadroga Act regulations. In any event, the new CMO will have no bearing on any motion practice testing the sufficiency of new pleadings. Motions and sufficiency of pleadings will be evaluated under Federal Rule 8.
9. At my direction, Plaintiffs’ Liaison Counsel prepared a report setting forth the names and docket numbers of all Plaintiffs remaining in this litigation. At the conference, Defendants suggested the numbers differ from their own perception

of the number of remaining cases. By March 20, 2011, the parties shall submit a joint letter to the Court that identifies, by name and docket number, each and every Plaintiff remaining in the 21 MC 100 and 21 MC 103 Master Calendars. Plaintiffs' Liaison Counsel's report is attached as an exhibit.

10. The next status conference is set for March 22, 2011 at 2:30pm. Before then, Plaintiffs' Liaison Counsel shall meet and confer with counsel for all continuing Plaintiffs and ascertain which, if any, have a genuine desire to proceed in litigation, notwithstanding the possibilities now offered by the Zadroga Act. The parties shall be prepared to address the issue of a stay because of the Zadroga Act. Defendants should evaluate the new complaints and be prepared to report on their intentions with regard to any motion practice.

Dear Judge Hellerstein:

Enclosed, Your Honor will find the following lists and information responsive to this Court's Summary Order dated January 20, 2011:

- "Opt-Out" Plaintiffs: The plaintiffs on this list are eligible for the World Trade Center Litigation Settlement Process Agreement, As Amended ("SPA") but did not opt in. See Exhibit "1".¹
- Disputed "Opt-In" Plaintiffs: The plaintiffs on this list are eligible for the SPA and want to settle their cases; however, these plaintiffs submitted their releases and second injury letters after January 5, 2011. Since the settlement documents for these cases were provided after January 5, 2011 the WTC Captive has taken the position that these cases are in dispute and have refused to accept these releases. It was agreed at the last conference before this Court on December 22, 2010 that each of these plaintiffs would have a fair amount of time to complete their opt-in paperwork. Each of these plaintiffs have different reasons for their delay as indicated on Exhibit "2" herein, but in general all have decided to Opt-In as a result of this Court's efforts and those of its Special Counsel Michael Hoenig.

By this letter, we respectfully request this Court to enter an order deeming the settlement releases for those remaining plaintiffs on the list annexed here as Exhibit "2"

¹ Plaintiffs who are represented by Worby Groner Edelman & Napoli Bern, LLP who have affirmatively expressed their desire to opt-out of the SPA and continue with their lawsuit are identified with a "Y" in the last column of Exhibit 1.

timely filed and further directing that they be accepted by the Captive for inclusion in the SPA. The plaintiffs at issue were listed on the EPL and the Captive was unquestionably aware of their eligibility for the SPA. Moreover, as recently as the conference held on December 22, 2010, the Captive did not object to release papers being submitted until January 14 (*see* December 22, 2010 Conference Transcript at pp. 9-11). There is certainly no utility for the Captive to continue to litigate the claims of these individuals who were not only eligible to settle, but who have evidenced their desire and intent to accept the settlement and have executed their settlement papers and proffered them to the Captive. Upon this Court's entry of an Order deeming the opt-in documents for each of these cases timely submitted, each of these plaintiffs can get their benefits under the SPA and the MetLife insurance policy. There will be no prejudice to the WTC Captive or any individual since these plaintiffs were on the Eligible Plaintiff List for the SPA and the Captive was unquestionably aware they were potentially settling plaintiffs.

- Other Cases: The plaintiffs on this list were not included on the SPA Eligible Plaintiff List or, alternatively, are cases pending in the 21 MC 102 or 21 MC 103 Master Dockets. *See* Exhibit "3"

The following is a summary of these lists by Master Docket:

- Total 21 MC 100 Cases: 208
- Total 21 MC 102 Cases: 812
- Total 21 MC 103 Cases: 638

These lists contain cases in which the plaintiffs are represented by our office *as well as* those cases where the plaintiff(s) are represented by other attorneys. It is possible that there are other active cases pending in these Master Dockets that are unknown to our office.
