

**ORDER APPROVING ACCOUNT AS A QUALIFIED SETTLEMENT FUND
PURSUANT TO TREASURY REGULATION SECTION 1.468B**

WHEREAS, the Cannata/Grochow Plaintiffs, the Defendants, and their contributing insurers, if any (collectively, the "Settling Parties") have agreed upon Settlements, and the settlements and allocations premised upon a comprehensive settlement plan, having been approved by this Court in the above litigation, all by which the Settling Parties agreed to the complete settlement of certain actions that allege personal injuries associated with the exposure to toxic and caustic dust, as alleged by the Cannata/Grochow plaintiffs, arising from the clean up services provided by the Cannata/Grochow Plaintiffs in 72 buildings surrounding Ground Zero arising from the hijacking and subsequent crashes of American Airlines Flight 11 and United Air Lines Flight 175 on September 11, 2001 resulting in destruction of the World Trade Center Towers and surrounding properties;

WHEREAS, the respective settlement agreement between and among the 82 Plaintiffs and the Defendants associated with these 72 buildings provide, for the establishment of an account that qualifies as a Qualified Settlement Fund into which the settlement funds shall be paid by each respective Defendant;

WHEREAS, the account, to be named the Cannata & Grochow WTC Disaster Site Fund (here, the “Fund”) furthers the purpose of resolving all of the claims brought by the Cannata/Grochow Plaintiffs against the Defendants to the instant litigation, as further identified in Exhibits A and B, respectively, to a Motion to Establish Account as a Qualified Settlement Fund, ECF filed with this Court on June 19, 2015 (the “Motion”), each claim for which alleges liability arising out of tort, labor law violations, negligence and breach of contract, or violation of law; and

WHEREAS, the Court has reviewed the Motion, which establishes the terms and conditions according to which the Fund shall be established.

WHEREAS, under the terms and conditions of the settlement agreements, general releases and term sheets, to the extent applicable, between the Settling Parties, the Fund shall be segregated from other assets of the Defendants and their contributing insurers, if any;

NOW, THEREFORE IT IS ORDERED THAT:

1. The Fund shall be established pursuant to and consistent with the Settlement Agreements, General Releases and Term Sheets, to the extent applicable, and the Escrow Agreement.
2. The Fund shall be established as a Qualified Settlement Fund within the meaning of Treasury Regulation Section 1.468B-1; and pursuant to this Court’s subject matter jurisdiction under Treasury Regulation Section 1.468B-1(c)(1).

3. The Garretson Resolution Group, Inc. is appointed as Fund Administrator pursuant to the terms, conditions and restrictions of the Motion, and the respective settlement agreements, general releases and term sheets, to the extent applicable, between and among the Settling Parties.
4. The Fund Administrator in conjunction with Wells Fargo Bank NA (the "Bank") shall take action to ensure that a proper account is opened, settlement funds invested consistent with the terms, conditions and restrictions of the Motion, and settlement proceeds deposited into the Fund by, or on behalf of the Defendants, will be distributed as provided for in the settlement agreements, general releases and term sheets, to the extent applicable, and the Motion, with the Fund Administrator, in consultation with the counsel for the Cannata/Grochow Plaintiffs being responsible for instructing the Bank to make distributions consistent with the terms of the respective settlement agreements, general releases and term sheets, to the extent applicable.
5. The Fund Administrator is authorized to coordinate all necessary distributions in a manner and form as prescribed by the settlement agreements, general releases and term sheets, to the extent applicable, including the payment of taxes, if any, attorney's fees and litigation expenses to counsel consistent with contingency fee agreements and as further ordered by the Court, and is authorized to effect any qualified assignments that relate to payments to or for the benefit of the Cannata/Grochow Plaintiffs, or non-qualified assignments that relate to

the payment of attorneys' fees to Gregory J. Cannata & Associates and to Robert A. Grochow, P.C., such that attorneys' fees may be paid as a lump sum, or as periodic payments, solely for the convenience of the Cannata/Grochow Plaintiffs.

6. The Fund Administrator is authorized, upon completion of all Fund Settlement Agreements, activities and final distribution of all settlement proceeds paid into the Fund by the Defendants, their claims administrators, and / or their contributing insurers, if any, to take appropriate steps to wind-down the fund and thereafter the Fund Administrator is discharged from any further responsibility with respect to the Fund.

7. Upon the establishment of the Fund and initial deposit of settlement funds, the Fund Administrator will file with the Court an accounting which a) acknowledges receipt of funds and describes the amount deposited, and b) describes the processes governing receipt, distribution and tracking of the funds. At three months after initial funding of the Fund, the Fund Administrator shall file a supplemental report with the Court describing deposits, distributions, and amounts remaining in the Fund, if any. Subsequent to final distribution of all sums within the Fund and wind-down of the Fund, the Fund Administrator shall file a final accounting with the Court describing deposits, distributions, and such wind-down.
