Why:

New York State Court's budgets were cut by \$170 million and Federal Court budget cuts raise serious concern. As a result of continuous budget cuts, the American Bar Association called on "bar associations to document the impact of funding cutbacks" on the judiciary.

NYCLA took action by compiling two <u>reports</u> on the effects of the cuts and <u>questionnaire</u> highlighting the effects of the judicial budget cuts. This hearing is part of NYCLA's ongoing initiative to assess the repercussions of the budget cuts on the public, practitioners and court personal.
