Introduction

This guide contains the statistical case opening codes used to electronically open and file new civil cases. The intention of the guide is to make everyone's task easier, whether they are entering data or inquiring into the CM/ECF database.

Entering Statistical Information for Civil Cases in CM ECF

The purpose of the civil cover sheet is to assist with gathering statistical information. The filed document (the complaint or other initiating document) should rule, not the civil cover sheet. If the civil cover sheet conflicts with the actual document(s) filed, or isn't accurate, get the information from the initiating document. It is best to review the complaint or initiating document to obtain information such as the jurisdiction, cause of action, nature of suit, citizenship, jury demand, \$ demand, and county.

Once case opening information is entered in CM/ECF at the initiation of a case, the data is stored for statistical reporting to the Statistical Division of the Administrative Office. Statistical information submitted to the Administrative Office by the District CM/ECF system is used for the Annual Report of the Director to the Judicial Conference pursuant to Title 28 Section 604(a)(3).

Additionally, the data is used for special reports provided to committees of the Judicial Conference and Congress, and for studies conducted by research agencies. It is very important that the user enters the correct statistical information when opening a civil case in CM/ECF.

OFFICE CODES

The office codes are the divisions within the Southern District of New York. You may not choose a division based on your personal preference, you must select the division based on your answers to the section labeled 'This action should be assigned to", on the Civil Cover Sheet.

CASE TYPE CODES

Case type codes are provided to assist the court in identifying the type of case that is being filed. For Civil case filing, only case type code "cv" is available.

DATE FILED

The Date filed is the date the action is initiated in the court.

Date filed

When opening civil cases, the Date filed field will default to today's date. It is a hard coded field and cannot be changed by the filer.

OTHER COURT INFORMATION

Other Court Name and Other Court Number are provided to assist the court in identifying the information from the Court the case is being removed from.

DOLLAR DEMAND CODES

Demand (\$000) is a number representing the dollar amount demanded in thousands, up to four digits. Dollar demand code must not exceed more than 4 digits. If dollar demand code exceeds more than 4 digits, the A.O. will not recognize the amount and a Statistical Error will be created for the civil action.

COUNTY CODES

County is a statistical code for the county of residence of the first listed plaintiff in all actions except U.S. government plaintiff and land condemnation actions. If the U.S. government is the plaintiff, enter the statistical code for the county of residence of the first listed defendant. In land condemnation cases, use the location of the tract of land involved. Special codes are provided for "Within U.S. but outside home state" (XX Out of State) and "Outside U.S." (XX Out of U.S.). This allows the clerk to deal with codes for only the state in which the local district is located. A code, however, must be entered for every action reported.


- If you are filing an action on behalf of the United States, select "none (no fee required)".
- If you plan to pay filing fees online with a credit card through Pay.gov at the time of filing, select "pd (paid)".
- If you are filing a motion to proceed informa pauperis, select "pend (IFP pending)".
- If you are filing a Jones Act case without prepayment of fees select "due (due)".
- If you are filing an action in which the fee is waived by statute, select "wv (waived)".

Error messages will appear on the screen to inform the user that information for a field is missing or information is not compatible with CM/ECF guidelines.

Other Court Name and Other Court Number fields

When filing a Notice of Removal or an Agriculture Appeal, on the main screen of the initiation of the case both Other Court Name and Other Court Number fields must be filled in. If the user omits one field, the system will display a message indicating that the user must enter both other court name and other court number. Press [OK] to clear the message and enter the omitted information.

Example: Error message that appears when one field is omitted for other court information.



Error messages will appear in the screen to inform the user that information for a field is missing or information is not compatible with CM/ECF guidelines.

Nature of Suit and Jurisdiction combination

The nature of suit and jurisdiction codes may be valid individually, the combination might be invalid and will result in the following error message: Error message: Invalid Nature of Suit/Basis of Jurisdiction combination. The system will display the valid Jurisdiction codes for the Nature of Suit code entered. Press [OK] to clear the message and reenter the correct combination.

Example: Error message that appears when Nature of Suit and Jurisdiction combination is entered incorrectly.




Error messages will appear in the screen to inform the user that information for a field is missing or information is not compatible with CM/ECF guidelines.

Discontinued Nature of Suit and Jurisdiction combination

A discontinued nature of suit code may not be used when entering the nature of suit information. The CM/ECF system allows only valid nature of suit codes in combination with jurisdiction codes. If a discontinued nature of suit is selected, an error message will display: Invalid Nature of Suit/Jurisdiction combination. Valid Jurisdiction code(s) for Nature of Suit are none []. Press [OK] to clear the message and reenter a valid nature of suit.

Example: Error message that appears when discontinued Nature of Suit and Jurisdiction combination is entered.



Error messages will appear in the screen to inform the user that information for a field is missing or information is not compatible with CM/ECF guidelines.

Citizenship Plaintiff Defendant and Jurisdiction combination

If the value in the Jurisdiction field is "4" (diversity), data is required on the citizenship of the plaintiff(s). If the Jurisdiction field is not "diversity", leave this field blank. The system will display a message indicating that the user cannot enter Citizenship and Plaintiff and/or Citizenship of Defendant unless it is a diversity case. Press [OK] to clear the message and reenter the correct information.

Example: Error message that appears when Jurisdiction field is not diversity and information for Citizenship Plaintiff and/or Citizenship Defendant is selected.
